Enhanced Proliferation Control Initiative (“EPCI”)

The purpose of this letter is to seek your assistance in complying with U.S. Laws that control the export and re-export of U.S.-originating goods. Your kind assistance will facilitate a continuous and unrestricted flow of products from Covestro to you.

The U.S. Department of Commerce’s Bureau of Industry and Security (“BIS”) imposes requirements on exporters to ensure that items being exported are not destined for an improper end use or undesirable end-user, as defined in BIS regulations. The enclosed checklist is designed to assist us in meeting our legal requirement to prevent the proliferation of weapons of mass destruction and must be completed by the end user and/ or Covestro Affiliate on behalf of the customer prior to shipment of the first order. It is our obligation under the Export Administration Regulations to “know our customers” and to ensure compliance with these regulations.

Dear Covestro LLC,

We acknowledge that the product we are purchasing from you is subject to United States export regulations. We agree in advance to the following restrictions imposed by U.S. law.

- 1) We will not sell, otherwise transfer or re-export any Covestro product or any direct product thereof contrary to U.S. law.
- 2) We will not use Covestro product nor the direct product thereof in any of the following activities nor will we perform research using Covestro product for any of the following activities:

Nuclear Explosive Activities

- Developing, designing, manufacturing, constructing, testing or maintaining any nuclear explosive device, weapon or components or subsystems of such a device or weapon.

Unsafeguarded Nuclear Activities

- Developing, designing, manufacturing, constructing, operating or maintaining any nuclear reactor, critical facility for the fabrication of nuclear fuel, facility for the conversion of nuclear material from one chemical form to another, or separate storage installation, where there is no obligation to accept International Atomic Energy Agency (IAEA) safeguards at the relevant facility or installation when it contains any source or special fissionable material (regardless of whether or not it contains such material at the time of export), or where any such obligation is not met.

Safeguarded and Unsafeguarded Nuclear Activities

- Safeguarded and unsafeguarded nuclear fuel cycle activities, including research on or development, design, manufacture, construction, operation or maintenance of any of the following facilities, or components for such facilities:
 - a) Facilities for the chemical processing of irradiated special nuclear or source material;
 - b) Facilities for the production of heavy water;
 - c) Facilities for the separation of isotopes of source and special nuclear material; or
 - d) Facilities for the fabrication of nuclear reactor fuel containing plutonium.
- 3) We will not use Covestro product nor the direct product thereof for activities related to chemical or biological weapon research, design, development, production, testing, stockpiling, sale, installation, operation, maintenance or use.
 - 4) We will not use Covestro product nor the direct product thereof for activities or research related to missile research, design, development, production, testing, stockpiling, sale, installation, maintenance, operation or use (the term 'missiles' includes but is not limited to rockets and unmanned air vehicle systems) in or by one of the following countries: Bahrain, China, Egypt, India, Iran, Iraq, Israel, Jordan, North Korea, Kuwait, Lebanon, Libya, Macau, Oman, Pakistan, Qatar, Saudi Arabia, Syria, United Arab Emirates or Yemen.

- 5) We will not knowingly re-sell, re-export or transfer Covestro product nor the direct product thereof to entities involved in any of the above-mentioned activities.
